The **Check-Out Aisles ID** sign, where provided, shall be above the check-out aisle in the same location as the checkout aisle number or type of check-out identification. Accessible IBC 2021 1112.1.5 Entrances ID\* Accessible entrances are required to be identified by the International Symbol of Accessibility where not all entrances are accessible. Lot Loading Zones

IBC 2021 1112.1.4 (2902.4) Accessible toilet or bathing rooms are required to be identified by the International Symbol of Accessibility where not all toilet or bathing rooms are accessible. Public facilities shall be provided w/ signs that designate the sex. Signs shall be readily visible and located near the entrance to each toilet facility.

Accessible Loading Zones are required to be identified by the International Symbol of Accessibility.

Alarm Call Fire Department IBC 2021 [F] 907.4.2.4 Where fire alarm systems are not monitored by an approved supervising station, an approved sign shall be installed next to each manual fire alarm box that reads: WHEN ALARM SOUNDS CALL FIRE DEPARTMENT. Exception: Where the manufacturer has permanently provided this information on the manual fire alarm box.

Alarm Warning Leakage IBC 2021 [F] 415.9.1.5

An approved automatic alarm shall be provided to indicate a leak in a storage tank and room. An approved sign shall be posted on every entry door to the tank storage room indicating the potential hazard of the interior room environment, sign shall state, "WARNING, WHEN ALARM SOUNDS, THE ENVIRONMENT WITHIN THE ROOM MAY BE HAZARDOUS."

Alarm Warning Fire Extinguisher IBC 2021 [F] 904.3.4 Where alarms are required to indicate the operation of automatic fire extinguishing systems, distinctive audible and visible alarms and warning signs shall be provided to warn of pending agent discharge.



IBC 2021 [F] 916.9 Signs shall be provided adjacent to gas detection system alarm signaling devices that advise occupants of the nature of the signals and actions to take in response to the signal.

Doors into electrical control panel rooms shall be marked with a plainly visible and legible sign stating "ELECTRICAL ROOM" or similar approved wording. The disconnecting means for each service, feeder or branch circuit originating on a switchboard or panel board shall be legibly and durably marked to indicate its purpose unless such purpose is clearly evident.

#### IBC 2021 [F] 914.2 Mechanical Room, Riser Room,

Rooms containing controls for air-conditioning systems, sprinkler risers and valves or other fire detection, suppression or control elements shall be identified for the use of the fire department.

IBC 2021 1013.1 Exits and exit access doors shall be marked by an Illuminated exit sign visible from any direction of egress travel. The path of egress travel to exits and within exits shall be marked by illuminated exit signs to clearly indicate the direction of egress travel. Intervening means of egress doors within exits shall be marked by illuminated exit signs. Exit sign placement shall be such that any point in an exit access corridor or exit passageway is within 100' or the listed viewing distance of the sign, whichever is less, from the nearest visible exit sign.

#### IBC 2021 1013.2

Exit - Low Level Signs

Where exit signs are required in Group R-1 by Section 1013.1, additional low-level exit signs shall be provided in all areas serving guest rooms The bottom of the sign shall be not less than 10" or more than 18" above the floor. The sign shall be flush mounted to the door or wall. Where mounted on the wall, the edge of the sign shall be within 4" of the door frame on the latch side.

IBC 2021 [F] 912.4 Immediate access to fire department connections shall be maintained at all times and without obstruction by fences, bushes, trees, walls or any other fixed or movable object. Exception: Fences, where provided with an access gate equipped with a sign.

The fire command center shall be identified by a permanent easily visible sign reading "FIRE COMMAND CENTER" located on the door to the

IBC 2021 [F] 905.7.1 Cabinets shall be identified in an approved manner by a permanently attached sign with letters not less than 2" high in a color that contrasts with the background color, indicating the equipment contained therein.

Where floor level signs are provided in interior exit stairways and ramps, a floor level sign identifying the floor level in visual characters, raised

characters and braille complying with ICC A117.1 shall be located at each floor-level landing adjacent to the door leading from the interior exit

IBC 2021 3002.3 An approved pictorial sign of a standardized design shall be posted adjacent to each elevator call station on all floors instructing occupants to use the exit stairways and not to use the elevators in case of fire. The sign shall read: IN CASE OF FIRE, ELEVATORS ARE OUT OF SERVICE. USE EXIT STAIRS.
